The following fees are due at time of registration and are non-refundable:

REGISTRATION FEE- Non refundable fee.

YANKEE LEAGUE FEE: This is a non-refundable fee; the club has joined this league to give our kids more competitive swimming opportunities. You can read more information on them at www.yankeeswimleague.org

The following fee is optional:

USA MEMBERSHIP FEE- We made this fee optional now that the club has their own insurance.

Please keep in mind, if you choose to opt out of this fee your child(ren) will not be able to swim in ANY of the USA Swim meets at all. In order for your child(ren) to be able to swim in any of the USA Swim competitions'. You will need to pay the USA Swim fee. The wildcat swim club will be participating in the USA Swim Meets

The following fees are due at time of registration and are refundable:

REFUNDABLE FUNDRAISING – A refundable fundraising contribution, reduced for each net fundraising dollar earned that can be accounted for. In order to keep program fees minimal, the club relies on fundraising activities. In order to encourage fundraising as well as provide an option not to participate we have instituted a refundable fundraising program.

Your refundable fundraising fee will be partially or fully refundable based on your fundraising efforts. In order to be successful we need your help and cooperation. Credit will also given for your volunteering efforts such as board participation, running concessions and banquet coordination. Please note that the Swim Derby is a mandatory fundraising event entirely for the end of season banquet and cannot be used to against refundable fundraising fees.

Program fees are payable in the following manner:

Refund of 50% of amount paid if withdrawal in writing made prior to 10/31. Payments must be paid by due date to be eligible for refunds. Payments made in advance of the due date will be reimbursed 100%. {example : if you paid 100% program fees at registration and you withdraw your child in writng on 10/15, you will receive 50% of amount due at registration plus 100% of the balance.}

Refundable fundraising fees will be refunded based on written withdrawal on a pro-rata basis:

2 weeks notification by 10/15	100%
4 weeks notification by 10/31	50%

Participants will be automatically withdrawn if payments are not made within 2 weeks of due date.

Additional payment schedule arrangements may be made upon board approval. Installment fees may apply.
